MAKE ABD YOUR PRIMARY FINANCIAL INSTITUTION

Effective November 1, 2021, if you have credit union deduction (*payroll deduction*), Stellantis has selected to discontinue this program. This means that all employees of Stellantis will only be allowed to have one direct deposit of total net pay. All employees have the ability to elect a credit union or a bank to have their entire pay directly deposited. If you do not make a

bank to have their entire pay directly deposited. If you do not make a selection before November 1, 2021, Stellantis will automatically re-route your payroll deduction to the bank account where your direct deposit currently resides. Any rejected funds are returned to Stellantis by the credit union or bank and will be paid to the employees via paper check. The final Credit Union Deduction will be on October 29, 2021. Employees can change their direct deposit account on file with Stellantis at any time. What you can do?

- ♦ Select Direct Deposit and enter Routing Number 272 485 673 and enter your account number. Verify banking information entered then submit. The new account will be sent through the prenote process to verify bank info and if correct, the new account will be used in 7-10 days.
- ◆ To change your pay Option, visit the Hub and log into ePay (https://fca.fyi/ePay)
- ♦ Select "Pay Option" from the side of the menu
- ◆ Under Change Pay Option to new account, select change and enter Routing Number 272 485 673 and enter your account number. Select the desired Interim Pay Option and click next. Verify banking information entered then submit. The new account will be sent through the prenote process to verify bank info and if correct, the new account will be used in 7-10 days.

Due to COVID-19 mandates, please call 1-586-751-3180 to register for the meeting. (It is mandatory to Wear A Mask)

Election of officers to the Board of Directors and the Credit Committee will be held. To be eligible for election to the above offices, individuals must be a member in good standing of ABD. The individual must obtain a petition from the Secretary of the Credit Union at the Main Office, 27850 Mound Rd, Warren, Ml.

Only petitions provided by the secretary of the credit union will be accepted. Petitions submitted must be signed by the members in good standing with ABD. The member must print their name as well as provide their signature. For account verification the member must list their account number or the last four numbers of their social security number. The petition must be submitted to the main office of the credit union by December 21st. The petition must contain a minimum of one (1) percent of the membership to be valid. In accordance with credit union bylaws, nominations from the floor will not be accepted.
